The required text-to-speech software is the latest version of JAWS (Job access with Speech), as a survey indicated that this software is the most suitable for the target learners.  The criteria has been reviewed to '240V lithium battery'
3.	signaling. Kindly provide clarification ( See pages 111,112, 113 etc.  Android Tablets do not support MS Office 2019 Preinstalled, they only support google docs. Kindly provide clarity on this. ( See page 48 etc.)	As per the tender documents, MS Office 2019 is required for laptop computers only.
4.	Android OS is not compatible with Laptops, but rather used on mobile devices and tablets. Chromebooks are the standalone laptops that run Chrome OS — which is the same family as Android OS. (See pages Page 62 etc.)	<ul> <li>The required operating system for both laptop computers and the tablet computers are "Latest Windows Preinstalled".</li> <li>All laptop computers and the tablets should come preinstalled with the latest Text-to-speech software - JAWS</li> </ul>
5.	Confirm licensing mode required for the Assistive technology software; is it perpetual, subscription or can it be either?	The requirement is a perpetual license for the Assistive technology software.
