

## REVOCATION OF NETWORK FACILITY PROVIDERS (NFP) LICENCES

The Authority published in the Kenya Gazette vide Gazette Notice Vol. CXXVI - No. 185 dated October 31<sup>st</sup> informing the public of the intention to revoke licences of Network Facilities Providers within seven days from the date of the Gazette Notice.

Consequently, the following Network Facility Providers' licences have been revoked.

The areas of non-compliance that necessitated the revocations for the NFP licence are detailed below

- Failure to submit operating information through Compliance Returns Condition 21.3
- Failure to submit Audited Accounts to enable computing your Annual Operating License fees and Universal Service Fund Levy, respectively Condition 20
- Failure to Submit Audited Accounts to enable computing your Annual Operating License fees and Universal Service Fund Levy, respectively Condition 20
- Failure to submit any of the requisite compliance renewal documents; Tax compliance certificate & Shareholding Certificates CR12-Condition 21.2
- Non-payment of requisite regulatory fees Condition 28
- Failure to submit of annual operating compliance certificate Condition 21.4
