

REVOCATION OF APPLICATION SERVICE PROVIDERS (ASP) LICENCES

The Authority published in the Kenya Gazette vide Gazette Notice Vol. CXXVI - No. 185 dated October 31st 2024, informing the public of the intention to revoke Application Service Providers (ASP) licences within seven days from the date of the Gazette Notice.

Consequently, the following ASP licences have been revoked.

The areas of non-compliance that necessitated the revocations for the ASP licence are detailed below

- Failure to submit operating information via Compliance Returns - **Condition 21.3**
- Failure to submit Audited Accounts to enable computing of Annual Operating License fees and Universal Service Fund Levy, respectively - **Condition 20**
- Failure to Submit Audited accounts to enable computing of Annual Operating License fees and Universal Service Fund Levy, respectively - **Condition 20**
- Failure to submit any of the requisite compliance renewal documents; Tax compliance certificate & Shareholding Certificates CR12- **Condition 21.2**
- Non-payment of requisite regulatory fees - **Condition 28**
- Failure to submit of annual operating compliance certificate - **Condition 21.4**
